SUBJECT: Command Policy Letter #8, Joint Service Off-Limits Establishments

1. In accordance with the Joint Off Limits List MOU (AR 190-24, Chapter 1, Section II, 1-9b (3)) signed 1 March 2016, the Commanding General, Headquarters, 1st Armored Division and Fort Bliss, prohibits Service Members of Fort Bliss, White Sands Missile Range and Holloman Air Force Base from patronizing the following establishments pursuant to Army Regulation (AR) 190-24, Armed Forces Disciplinary Control Board and Off-Limits Installation Liaison and Operations, 27 July 2006:

e. Best Food Mart, 6200 Dyer Street, El Paso, TX 79904 (detrimental to welfare of Service Members).

f. Station Recreation, 1621 Appaloosa Drive, Sunland Park, NM 88603 (detrimental to welfare of Service Members).

g. Bo-De-Gas Graff Head Shop, 1791 Zaragoza, Suite C, El Paso, TX 79936 (detrimental to welfare of Service Members).

h. Bo-De-Gas 2 Graff Head Shop, 4801 Montana, El Paso, TX 79903 (detrimental to welfare of Service Members).

i. Dyer Smoke Shop, 8500 Dyer Street, Suite 9, El Paso, TX 79904 (detrimental to welfare of Service Members).

2. Service Members from Fort Bliss, White Sands Missile Range and Holloman Air Force Base are ordered not to enter or patronize these off-limits establishments or their locations. Violations of this order are punishable under Article 92, Uniform Code of Military Justice.

4. This memorandum supersedes all previous 1st Armored Division and Fort Bliss, White Sands Missile Range and Holloman Air Force Base Off-Limits Lists.
